DECLARES

- that Metalsistem products conform with the European Directive n°2001 of 1995 regarding the general safety of products. This directive has been transposed into Italian law in the form of Legislative Decree 172/04;
- that it is certified ISO 9001:2015 – Quality Management System;
- that it is certified ISO 14001:2015 – Environmental Management System;
- that it is certified ted “AEO” FULL – Authorized Economic Operator;
- that it is certified OHSAS 18001:2007 – Occupational Health and Safety Assessment Series;
- that it is accredited by the Central Technical Service of Italy as a Fabrication Centre, and has been given a certificate of disclosure of business activity No. 753/10. That it acquires mill certificates for all material received from its steel suppliers and transforms this raw material in compliance with a ISO 9001:2015 certified quality management system. It also conducts laboratory tests on coil samples to monitor the quality standards of its supplies;
- that Metalsistem structural products are manufactured in accordance with Regulation N° 305:2001/EU (construction products regulation) with in-factory monitoring of manufacturing in accordance with EN 1090-1:2012/A1:2011 within the framework of the 2+ system (CE marking);
- that Metalsistem racking and shelving conforms with current occupational health and safety requirements established in Italian legislative decree 81/2008;
- that all cold formed components are manufactured from 3.1 certified structural steel pursuant to UNI EN 10204, in accordance with UNI EN 10149 and UNI EN 10346 standards;
- that Metalsistem S.p.A. is a member of the Industrial Racking Industry body CISI (Italian Manufacturers of Industrial Racking – member of ANIMA-AISEM, FEM associate). This body sets out structural design, safety and control standards, with which METALSISTEM complies for all structural components described in its catalogues. The CISI also ensures compliance with Italy’s “safe product” legislative decree;
- that the welding process is continuous and automatic industrial process certified to ISO 3834;
- that this process is subject to constant internal controls, conducted by internal certified personnel under the UNI EN 287-1:2004 and UNI EN1418:1999 standards and by the company’s internal Quality Control Service as well as periodic inspection by external body RINA in accordance with ISO 9001;
- that all coating are eco-friendly (lead-free);
- that the steel sheet is produced using the Sendzimir Cr6-free galvanisation process;
- that its coils have a fire reaction class “A1” according to D.M. 10/03/05 annex C Decision 2000/147/CE standards and a fire reaction class “A1” according to UNI EN 13501-1:2009 standards, hence they do not participate to fire or propagation even in presence of a fully developed fire.
